# Drive4Stardum, LLC presents **FALL BALL**

This is the third annual Fall Ball which begins the first week of September 2009 and runs for 6 weeks.

Each session consists of drills and scrimmage time. This year we will have sessions during the week as well as the weekend based on the number of participants. Students of the game will become better defensive and offensive players through participation in drills that are designed to improve footwork, agility and speed.

With these skills players are able to position themselves for rebounding, shielding defender as they navigate their way to the basket using ball handling skills. Additionally, participants will learn to effectively communicate with teammates as they learn how to defend the pick and roll as well as make better decisions reading defenses.

Drive4Stardum will have one session geared towards watching film pointing out moving without the ball on offense and position on defense. A participant must be in 4th grade through 12th grade in order to participate in Fall Ball.



## **OUR GOAL:**

Is to build on participant(s) weakness and enhance their strengths through drills and competition. Students of the game will have fun with the experience while at the same time learn important life skills through the sport such as teamwork, commitment, dedication, discipline, and respect for others.

## **COST & PAYMENT**

A non-refundable payment of \$150 is due with the application by July 1, 2009. A confirmation email will be sent to the participant once the initial payment is received.
